

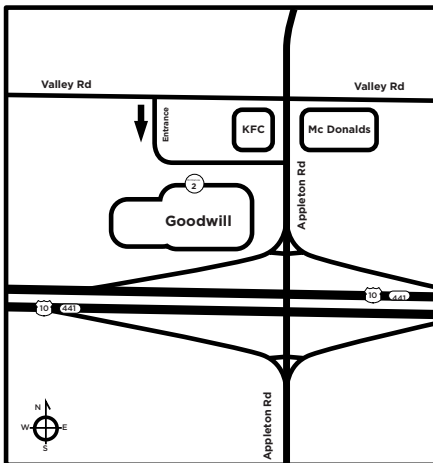

Goodwill industries nyob rau North Central Wisconsin yog ib lub koomhaum ntawm 165 lub koom haum uas nyob thooob plaws North America thiab lub ntiag teb. Nws yog ib lub ntawm pawg Goodwill Industries International thiab Rehabilitation rau Wisconsin, thiab nws tau ua haujlwm pab tej zos nyob rau hauv lub xeev no txij li thaum 1971.
